1. GENERAL CONDITIONS

- This Lorry Receipt (LR) / Goods Consignment Note is issued subject to the terms and conditions mentioned herein.
- The transporter acts as a carrier/broker and not as the owner of the goods.
- All disputes are subject to the jurisdiction of courts at the place of booking.

2. LIABILITY & INSURANCE

- Goods are carried at owner's risk. The consignor/consignee is advised to insure the goods.
- The transporter shall not be liable for any loss, damage, deterioration, or delay caused by force majeure, natural calamities, riots, strikes, accidents, or any circumstances beyond control.
- In case of any accident, the insurance claim shall be filed with the truck owner's insurance company. The transporter/broker is not liable for any loss.
- Maximum liability of the transporter, if any, shall not exceed the freight amount charged.

3. FREIGHT & PAYMENT

- Freight charges are as per the agreed rates and are payable as mentioned in the LR.
- Any demurrage, detention, or additional charges shall be borne by the consignor/consignee as applicable.
- No deduction from freight shall be allowed for any reason including damage or shortage.
- Payment of freight does not constitute acceptance of goods in good condition.

4. DELIVERY CONDITIONS

- Delivery shall be made to the consignee or their authorized representative against proper identification.
- The transporter reserves the right to refuse delivery if proper documents are not presented.
- Goods not taken delivery within 7 days of arrival shall attract storage charges.
- The transporter is not responsible for any delay in delivery due to traffic, road conditions, or government regulations.

5. CLAIMS & DISPUTES

- Any claim for loss or damage must be lodged in writing within 24 hours of delivery.
- Claims not lodged within the stipulated time shall not be entertained.
- The transporter's liability ceases once goods are delivered and acknowledged.
- All disputes shall be settled through arbitration as per the Arbitration and Conciliation Act.

6. PROHIBITED GOODS

- The transporter shall not be responsible for carrying prohibited, hazardous, or illegal goods.
- The consignor warrants that the goods are legally permitted for transportation.
- Any penalty or fine due to misdeclaration shall be borne by the consignor.

7. GST & COMPLIANCE

- GST and other applicable taxes shall be charged as per government regulations.
- E-way bill and other statutory documents must be provided by the consignor.
- The transporter is not responsible for any penalty due to non-compliance by consignor/consignee.
